- The best way to verify income is by using the IRS Data Retrieval Tool (DRT) on the FAFSA. If you or your parent(s) have not already used the tool, go to <u>FAFSA.gov</u>, log in to the 2023-2024 FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. From there, follow the instructions to determine if you are eligible to use the IRS DRT to transfer 2021 IRS tax information into the FAFSA. After uploading tax data, **please be sure to submit the FAFSA.**
- To obtain a 2021 Federal Tax Return Transcript from the IRS, go to www.IRS.gov and click on the "Get Your Tax Record" link, or call 1-800-908-9946. Make certain to request the "IRS Tax Return Transcript" and not the "IRS tax account transcript." It takes up to 2 weeks for IRS income information to be available for electronic IRS tax filers, and up to 8 weeks for paper tax return filers.
